Context and purpose

The Monaro Rail Trail (MRT) – a shared multi-use pathway – will be one of Australia's longest rail trails, running 213km between Queanbeyan and Bombala along the disused NSW Government railway corridor. The corridor runs through Snowy Monaro Regional Council (SMRC) Local Government Area (LGA) and the Queanbeyan Palerang Regional Council (QPRC) LGA.

32km of the QPRC LGA corridor borders the Australian Capital Territory (ACT).




Figure 6 The MRT at a glance

The purpose of this document is to:

- 1. Guide community engagement for the Monaro Rail Trail (MRT) beyond October 2022;
- 2. Document consultation from October 2015 to the current date; and
- 3. Demonstrate evidence of community support.

The document sets out:

- Stakeholders interested in and/or impacted by the project;
- Consultation and communication products developed to engage stakeholders;
- The decision-making framework that determines when consultation or communication with stakeholders might or must take place;
- A record of consultation; and
- Evidence of community support gathered from principal consultations to date.

The document is supported by:

- *History of the Monaro Rail Trail* which describes consultations from the earliest discussions in October 2015 to June 2022;
- An evidence base of community support (emails, letters and online comments received from stakeholders from July 2015 to the present day;
- MRT Meeting Register; and
- MRT Member Register (individual, family, community groups and businesses)


Decision-making framework

There is a commitment from MRT Inc that it will respect the diverse range of interests and views which may exist around the MRT and make genuine attempts to elicit those interests and reviews, consider feedback and resolve conflicts, while recognising that it has the ultimate decision-making role.

MRT Inc gathers valuable feedback through its consultations—both specific to the issue under consideration and on related issues. Where resourcing and systems allow, MRT will capture, collate and analyse this data, and will aggregate and share this data with the community with stakeholders in accordance with the Stakeholder Matrix and Consultation and Communication Products and Channels described in this document.

This will help to build a database of knowledge about the views, needs and aspirations of the communities adjacent to the rail corridor and the users of the MRT and how those views, needs and aspirations evolve and develop over time.

Principal consultations

What	Targeted consultation: SMRC and QPRC
Why	The two councils will be lessees of the rail corridor and responsible for its management.
When	From conception of the MRT proposal and ongoing, currently as working group meeting fortnightly.
Who	Mayors, councillors and staff of SMRC and QPRC.
Where	Council chambers.
How	Initially presentations to introduce the proposal, then presentations to update and now meetings to progress the proposal. A working group of SMRC, QPRC and MRT Inc now meets fortnightly.
Outcome	As the proposal has developed, council involvement has increased. Councils have: funded the MRT Feasibility Study 2019, the MRT Trail Development Plan 2022 and signed an MOU with MRT Inc, in Sept 2022 applied for and received a \$272K grant from Regional NSW for business case development.

What	Targeted consultation: landholders part 1
Why	To ensure landholders with property adjoining the rail corridor were aware of the general MRT proposal. This is prior to feasibility studies and trail development plans.
When	2018 to 2021.
Who	Farmers with property adjoining the rail corridor in southern sections. See detailed record page 22.
Where	Cooma to Bombala.
How	Phone calls by resident MRT Ambassadors and in person discussions with MRT Ambassadors.
Outcome	Fifteen landholders from Nimmitabel to Bombala were contacted, these few own most of the land along the rail corridor. Most were positively supportive, some were neutral but would not oppose the rail trail, some wanted more information on specific impact on their property, only a few were opposed.



What	Targeted consultation: landholders part 2
Why	To ensure individual landholders with property neighbouring or dissected by the corridor had their concerns noted and discussed at the time of Trail Development Plan Stage 1.
When	January 2022.
Who	Landholders adjacent to rail corridor and in sections being assessed for the Trail Development Plan Stage 1 (TDP) were given the opportunity to meet the TDP consultants.
Where	Rail corridor from Tralee to Michelago and Jincumbilly to Bombala.
How	Landholders advised by SMRC and QPRC that the TDP consultants were available for a phone meeting or an in-person meeting when the consultants traversed the corridor adjacent to their land. QPRC issued 38 letters and SMRC 163 letters.
Outcome	Eight landholders took the opportunity for face-to-face discussions with the consultants and four used a phone consultation. The consultants' reported that all landholders were satisfied their concerns could be addressed.

What	Targeted consultation: landholders part 3
Why	To ensure individual landholders with property neighbouring or dissected by the corridor had their concerns noted and discussed at the time of Trail Development Plan Stage 2 and for the Biosecurity and Biodiversity Assessment.
When	September 2023.
Who	Landholders adjacent to rail corridor and in sections being assessed for the Trail Development Plan Stage 2 (TDP) were given the opportunity to meet the TDP consultants.
Where	Rail corridor from Queanbeyan to South Jerrabomberra and Michelago and Cooma.
How	Landholders advised by SMRC and QPRC that the TDP consultants were available for a phone meeting or an in-person meeting when the consultants traversed the corridor adjacent to their land. 62 letters issued by QPRC and 536 by SMRC.
Outcome	Fewer than 10 landholders took the opportunity for face-to-face discussions with the TDP consultants and four used a phone consultation. The consultants' reported that all landholders were satisfied their concerns could be addressed. Four landholders prepared written submissions to the Biosecurity consultants.



What	Targeted consultation: landholders part 4
Why	To ensure individual landholders with property neighbouring or dissected by the corridor had their concerns noted and discussed at the time of the Biosecurity and Biodiversity Assessment.
When	August to November 2023.
Who	Landholders adjacent to rail corridor and in sections being assessed for the Biosecurity and Biodiversity were given the opportunity to meet the consultants.
Where	Rail corridor from Queanbeyan to South Jerrabomberra and Michelago and Cooma.
How	Landholders advised by SMRC and QPRC that the consultants were available for written comment on the MRT proposal and biosecurity issues. 62 letters issued by QPRC and 169 by SMRC.
Outcome	Four landholders took the opportunity to provide written comment. Three commented on potential weed spread and one commented on riders alarming stock.

What	Targeted consultation: Cooma Monaro Rail Inc
Why	To investigate potential for a joint rail trail and tourist train on part of the corridor from Cooma to Nimmitabel.
When	August 2020 to current.
Who	MRT Inc, CMR Inc and SMRC. Recent meetings chaired by SMRC. See detailed record page 28.
Where	Cooma Railway Station and SMRC chambers.
How	Meetings. An initial series of presentations by MRT and CMR followed by discussions to find common ground that would benefit both groups.
Outcome	Agreement that both activities are synergistic. A business case is to be developed for the joint corridor on a section between Cooma and Bombala. In the meantime, advance the MRT proposal for northern sections of the rail corridor – Queanbeyan to Cooma.

How	'Open house' sessions were conducted in each of the above communities with the Feasibility Study consultants on site, supported by visual displays. Attendees were able to ask questions of the consultants.			
	This series of consultations was advertised by a press release in addition to a letter mailed by SMRC to 500 landowners adjoining the rail corridor.			
Outcome	Data available from the report shows attendance as: Michelago 35; Bredbo 12; Cooma 25; Nimmitabel 12; Bombala 10.			
	The Feasibility Report indicates the vast majority of those attending were supportive of the MRT or satisfied after discussion with the consultants that any issues could be resolved.

Why	To test the integrity of the Feasibility Study prior to final draft.
When	December 2019 to January 2020.
Who	Residents in Snowy Mountains Regional Council LGA and the general public.

How	The SMRC <u>Have Your Say</u> portal was updated to include the MRT Feasibility Study and was open to the public for December 2019 to January 2020.
Outcome	509 responses were recorded, of which 95.9% were supportive of development of the MRT, 3% were opposed and 1.2% were undecided.
